Best Practices for Developments and Landowners in Blanco County

Why Best Practices

Significant development is occurring in Blanco County and across the Hill Country, as the region is recognized as one of the top areas to live and visit in Texas. Without thoughtful planning, development has the potential to adversely impact the natural infrastructure of the Hill Country that makes it such a desirable area, including our dark night skies, water availability, natural landscape, native animals and vegetation, and rural character. Growth and wine tourism, with increasing demands on water supply, could also threaten the viability of existing farms and ranchland.

Best Practices for Developments and Landowners in Blanco County were developed by BCCI in response to a grass roots effort by over 200 people concerned about the effects of developments on Blanco County. The top concerns were prioritized into four subcategories: Ground and Surface Water Conservation, Landscape and Wildlife Conservation, Night Sky Preservation, and Preservation of Agricultural Production and Protection of Rural Character and History. BCCI then surveyed existing literature on approaches to address these concerns. The best practices summarize practical approaches that can be used to successfully address the concerns. They contain brief summaries of key issues that should be considered during planning along with links to more detailed resources that can be used to create actionable plans.


These best practices are intended to be evergreen. We will update them as new information becomes available and to reflect community feedback. Please consider adopting these best practices, as appropriate, for your own property and as you interact with developers, government officials and conservation organizations.

How to Use the Best Practices:

- Developers should be encouraged to adopt the best practices in any development plans.
- POA's should implement some of the best practices, such as allowing rainwater harvesting and requiring dark-sky-compliant lighting, into deed restrictions, covenants and by laws.
- Landowners can adopt best practices in their land management plans.
- Government officials can encourage adoption of the best practices throughout Blanco County and where appropriate, reference best practices in County/City resolutions, ordnances, and development rules.





Road Conditions






Water Distribution System



REGULAR MEETING OF THE GOVERNING BODY OF THE CITY OF BLANCO

Meeting Minutes May 14, 2024

A regular meeting of the City Council, City of Blanco, Texas was held on May 14, 2024, at 6:00 pm at the Gem of the Hills, 2233 US-281, Blanco, Texas.

The meeting was called to order at 6:00 pm by Mayor Arnold, followed by roll call announcing a quorum was present. The Invocation and the Pledge of Allegiance was led by Dan Murrah. Council members present: Mayor Arnold, Mayor Pro-Tem Thrailkill and Council Members Smith, Swinson, and Moses.

City staff present: Warren Escovy, City Administrator, Laurie Cassidy, City Secretary, and Interim Chief/Lt. Jerry Thornhill.

Mayor Arnold made the following announcements:

- The burn ban is currently off.
- Water restrictions are currently at Stage 2, please be mindful of your water usage.
- This is National Police Week; he expressed his gratitude for the men and women in blue

Public Comments:

- William Depew, not a resident, spoke regarding election law and Dennis Moore's eligibility.
- Kenneth Welch, Blanco County resident, spoke regarding the election. He shared Grady Achiles removed himself from the ballot and spoke regarding Dennis Moore's eligibility.
- Jay Palmer, Blanco County resident, spoke regarding the election. He questioned Dennis Moore's eligibility and stated if Mr. Moore is appointed this will go to a District Court to decide.
- Waymond Lightfoot, City of Blanco resident, spoke about the election, Mr. Moore and horse racing fouls. He questioned Mr. Moore's eligibility and weather Mr. Smith should be elected.
- Gary Currier, Blanco ETJ resident, said he was going to speak about chickens but since the major topic is about elections he spoke regarding the dispute with Mr. Moore's voter registration and candidate eligibility.
- Susan Moore, City of Blanco resident spoke regarding the election. The city spoke and elected three persons and she believes these three should be our new city council members.
- Wayne Gosnell, wrote a letter to be read by Laurie Cassidy, City Secretary regarding Dark Sky Ordinance violations.

Staff Presentations:

- City Hall, Warren Escovy, City Administrator, shared the following: Lavender Festival is scheduled for June 7-9, meter audit update, lift station completion, discussed budget calendar, TWDB awards \$3.9 million, total \$512,000 in green funding grant. There will be no Finance presentation due to Sasha Ricks absence, the second quarter financials are in your packet.
- Police Department, Acting Chief/Lt. Thornhill did not present the April Monthly Report, except to say the numbers are down. He also spoke about police incentives program. The department is currently staffed at five and looking for new officers. The Receptionist position has been filled.

Mayor Arnold made a statement. Spoke with numerous persons, all said he has no choice but to certify this election as it stands. Where there is a dispute, he should rule in favor of eligibility.

Mayor Arnold certified new Council Members Bobby Mack-McClung, Candy Cargill, and Dennis J. Moore, Jr.

Consent Agenda: *The following items may be acted upon in one motion*. No separate discussion or action is necessary unless requested by the Mayor or a Council Member, in which those items will be pulled for separate consideration.

- 4. Approval of Ordinance 2024-O-003 General Election Canvassing the Returns and Declaring the Official Results of the May 4, 2024, General Election to Elect Three (3) City Council Members.

Council Member Smith requested Item 4 be pulled from the consent agenda and moved to New Business Item 2. Council Member Swinson requested Item 1 be pulled from the consent agenda and moved to New Business Item 1. Warren Escovy spoke regarding budget adjustment from minor equipment.

A motion was made by Council Member Smith to approve the consent agenda items two and three as presented, seconded by Council Member Moses, all in favor, motion carried unanimously.

New Business, Item 1, Let the minutes reflect Council Member Swinson left Executive Session at 9:00 pm, A motion was made by Council Member Smith to approve the minutes from the April 9, 2024 regular meeting, as amended, seconded by Council Member Swinson, all in favor, motion carried unanimously.

New Business Item 2, Council Member Smith thanked all for running for council and recused himself from the vote. A motion was made by Council Member Moses to approve Ordinance 2024-O-003 General Election Canvassing the Returns and Declaring the Official Results of the May 4, 2024 General Election to Elect Three (3) City Council Members, seconded by Mayor Pro-Tem Thrailkill, motion carried 3-0 with Council Member Smith recused.

Laurie Cassidy, City Secretary, Administered the Oath of Office to Newly Elected Officers Bobby Mack-McClung, Candy Cargill, and Dennis J. Moore, Jr.

New Business: Consider, discuss, and take appropriate action on the following:

- 1. Consideration, Discussion and Take Possible Action on Possible Vacancy on the Governing Body of the City of Blanco, including Possible Appointment to the Governing Body or Call of Special Election to fill a Vacancy, and any related, required Oath of Office. **No Action Taken**
- 2. Consideration, Discussion, and Take Possible Action on Approval of Mayor Pro-Tem. for the Term May 2024 through May 2025. A motion was made by Council Member Moses to appoint Bobby Mack-McClung as Mayor Pro-Tem for the term May 2024 to May 2025, seconded by Council Member Cargill, motion carried 4-0 with Mack-McClung abstained.
- 3. Consideration, Discussion, and Take Possible Action on Approval of Resolution 2024-R-011 Amending Resolution 2023-R-007 Designating Persons Authorized to Sign on the City's Depository Accounts as the Official Signatories of the City of Blanco. A Motion was made by Council Member Moses to Approve Resolution 2024-R-011 Amending Resolution 2023-R-007 Designating Persons Authorized to Sign on the City's Depository Accounts as the Official Signatories of the City of Blanco and appoint Council Member Swinson and Mayor Pro-Tem Mack-McClung as new check signers, seconded by Council Member Moore, all in favor, motion carried unanimously.
- 4. Consideration, Discussion, and Take Possible Action on Approval of Street Closures and use of Byars Building for Lavender Festival (June 7-9, 2024). Libbey Aly, Chamber of Commerce spoke of the need for street closures for Lavender Festival. They do not need access to the Byars Building. She also requested variance to allow vendors to park at the Pecan Bottom. A motion was made by Council Member Moses to allow for all necessary street closures, seconded by Council Member Moore, all in favor motion carried unanimously.
- 5. Consideration, Discussion, and Take Possible Action on Approval of Ordinance 2024-O-004 Repeal Ordinance Chapter 7 Health and Sanitation, Height of Weeds and Chapter 3 Animal Control Livestock (Ratifying and Confirming Previous Resolution of Council). A motion was made by Council Member Cargill, seconded by Council Member Swinson, all in favor, motion carried unanimously.
- 6. Consideration Discussion and Take Possible Action on Approval of Six Month Building Rental Contract Between the City and Gem of the Hills in the Amount of \$1,200.00 (June-November 2024). Council Member Moses does Council want to spend the \$200 per month to meet at Gem of the Hills. It was suggested that Council Members could use their stipend to pay this fee. Could we commit on a month by month basis? **No Action Taken**

STAFF REPORT: Thornhill Promotion

DESCRIPTION:

Promotion of Acting Chief/Lieutenant Jerry Thornhill from Lieutenant to Police Chief

ANALYSIS:

In late March of 2024 the Police Chief turned in his resignation and was put on paid administrative leave in early April before the Eclipse. There have been many changes at the Police Department but the one constant has been the leadership of the Acting Chief Jerry Thornhill. With continual law enforcement work since 1998 Thornhill has over 25 years of experience as a police officer at various levels. Thornhill has worked with the current staff and the City Admin to look at retention and recruitment tools.

His connections to the Blanco County Sherif's Department and the State trooper has allowed us to have a police presence on Hwy 281 even as we lost some officers due to other opportunities. Jerry has worked steadfast to make his community a safer one and has worked in this community for almost 14 years. My recommendation for Thornhill to be promoted to Chief is not because it's "due" but because I believe he is the best officer for the job. His commitment to the organization and this community is undeniable. He is known throughout the county and is a "team player" which is why we have the cooperation from other law enforcement agencies when we need it.

Former Chief Rubin was hired at \$88,000 in 2020 and was making \$105,000 when he retired. My recommendation for salary is starting him at \$92,000 with a merit review at 6 months. It is Administration's intent to make sure the Police Chief position is "slotted" at a higher rate than the Finance Director.

RECOMMENDATION:

Hire Acting Chief Thornhill to a salary of \$92,000 with a six month review and merit increase to at least \$95,000

STAFF REPORT: Agreement with Neighbor's Market

DESCRIPTION:

Development or shared cost agreement between the City of Blanco and Neighbors Market

ANALYSIS:

There is a need for a sanitary sewer line west of 281 and south of a manhole near 15th street. The entire area north of 15th is NOT served by City Sewer. Neighbor's Market requests a Sanitary sewer line to serve their property within 18 months and is willing to enter into an agreement to pay 25% of total costs (City 50%, Brewer to the north 25%). This would be a cost sharing agreement with a timeline attached. Neighbors Market is an owner who plans to build a convenience store, gas station, and retail on a 5 acre site with direct access to Hwy 281.

FISCAL IMPACT:

25% of a \$380,000 sewer line is worth about \$95,000. Providing sewer to an under served area has not yet been defined.

RECOMMENDATION:

Staff recommends that council direct staff to finish a cost sharing agreement with Neighbors Market


Option 2 - Open-Cut Parallel Along 281 South Bound





CITY OF BLANCO RESOLUTION NO. 2024-R-014

A RESOLUTION OF CITY COUNCIL OF THE CITY OF BLANCO, TEXAS ESTABLISHING GUIDELINES FOR THE DEVELOPMENT AND USE OF PECAN BOTTOM PARK

WHEREAS, the City of Blanco owns and operates a city park known as "Pecan Bottom Park" (the "Park") adjacent to and near the southeast corner of the City's main square;

WHEREAS, by resolution dated November 9, 2021, the governing body of the City designated the Park for future development as a "nature park";

WHEREAS, the City now wishes to elaborate upon and define current and future development and operational guidelines for the Park; and

WHEREAS, the City finds that the following resolution is in the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BLANCO, TEXAS THAT:

- 1. The following guidelines will apply to the Park's use and operation before and after such time as restoration and repair of the bordering rock wall along Town Creek takes place.
- 2. The rock wall repair will require a considerable amount of brush and tree removal, and use of heavy equipment; therefore, until completion of such project, the City will leave and maintain a "riparian zone" strip of approx. 15-20 feet along the creek bed in its natural state, without any mowing. The remainder of the property will be mowed and may be used as requested subject to City approval for event parking, no more than one event per month.
- 3. Once the rock wall is repaired and restored, the City will preserve the riparian area on the creek-side, and design and execute placement of a strip of "grass block pavers" approx. 22 feet wide along 2nd Street, with the middle portion being developed with sitting areas, a playscape, and other similar features. Final design shall be subject to approval by the City.
