**Discussion Items of the Committee:**

**1. Update: Previous Action Items**

- a. Confirm Planning Action Items for Initial Bond Tranche (2025-2026)
  - 1. SPI Engineering
    - a. Initial projects and implementation timelines of projects for presentation to Council for funding **2-year plan**:
      - i. Design, project execution and construction
  - 2. Timelines
    - a. Bond Sales
      - i. First tranche cost estimate
        - 1. Bond issuance fees
        - 2. Allocations (design, construction, project bids, contingencies, etc.)
      - ii. Dollar amount for initial tranche 2025-2026
        - 1. Confirm Compliance with Debt Reduction to New Debt- 5% Ratio
- b. Consensus for Infrastructure Prioritization Framework
  - 1. Confirm method for Council, Administration, CIAMAC and Consultants to have a clear understanding and execution of projects to meet timelines and funding.

**2. Discuss Type 1 Status and Next Steps**

- a. Discuss Type 1 water resources for augmenting water supply. Discuss the pros and cons for a long-term solution to secure multiple water supplies
- b. Confirm SPI assessment of routes and a ballpark estimate of a pipeline cost including using existing rights-of-way.
- c. Confirmed Grant Writer (Kanyon Payne), Project GC and Gaby Bolsnos with ReUse to attend CIAMAC meeting to provide a context for services associated with project development, funding options and expected timelines.
  - 1. Anticipate scheduling a Site Visit to SA Area of Technology currently in operations by ReUse and discussions with owners and operators.

### 3. UPDATE: 281 Bypass Route- Mitigation possibilities for TxDOT favored 281 Route

- a. Stream/creek impacts: Channel widening, erosion, and altered hydrology if crossings are replaced or widened.
- b. Flooding: Urban drainage systems may require upgrades to avoid downstream flooding.
- c. Pollutant loading: Runoff carrying oils, heavy metals, rubber particles, and de-icing chemicals flows into creeks, rivers, and groundwater.
- d. Habitat: Tree replacement (minimum 2:1), wildlife crossings/migration, dark-sky lighting
- e. Noise walls, rubberized asphalt, construction time limits, and vibration monitoring.
- f. Increased vehicle emissions: More lanes often induce additional traffic ("induced demand"), raising emissions of NO<sub>x</sub>, SO<sub>2</sub>, CO, PM<sub>2.5</sub>, PM<sub>10</sub>, and ozone precursors.
- g. Additional Thoughts:
  - i. Enhanced stormwater detention basins sized for future growth
  - ii. Water-quality treatment features (bioswales, sand filters, vegetated swales)
  - iii. Riparian buffer protections (minimum 100 ft where feasible)
  - iv. Prohibition of direct discharge into river/creek channels
  - v. Low-impact development (LID) features near sensitive drainage areas
  - vi. Culvert sizing that accounts for increased impervious cover
  - vii. Engineered slopes and erosion control to prevent sediment into the river

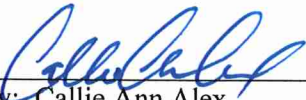
