NEW BUSINESS:

1. 1725 So Hwy 281 – Second Echo / Sone Property- Building Set Backs.

Mr. Sone spoke about the need for a variance of setbacks so they can build deck 20' off the rear property line, and on the North side 10' off property line to build a new larger deck in wooded area. The deck will be used for events and help comply with the Fire Marshall's requirement of limited capacity in building of 60. West is Yett Park & greenspace, and to the South and North are both commercial properties. The previous deck was built over the septic system and has since been torn down, and septic moved. The new deck will be larger however not be built over septic, or have any egregious lighting, and allow for the business to accommodate a larger capacity for events. Mr. Sone's deck contractor Shawn Cole came forward and showed the new deck plans to the Commissioners. Mr. Cole confirmed that no oaks would be disturbed, lighting would be placed under deck handrails, septic was moved, and now septic would not be hindered by the new deck. Warren Escovy, City Administrator confirmed neighbors were sent notices.
